## Universal Biosensors signs global deal with LifeScan.

Universal Biosensors, Inc. (ASX:UBI) is pleased to announce that it has entered into a global exclusive License Agreement with LifeScan Global Corporation ("LifeScan") to develop a biosensor, test strip and meter to be used for the detection and monitoring of diabetes in animals.

The Licence is a worldwide exclusive, transferable, sublicensable license to make, manufacture and sell a discrete single point measurement for blood glucose monitoring system that consists of a meter and strip for diabetes management in non-humans which is made or developed by UBI using LifeScan's technology. Whilst there are standard termination options available to both parties, once the product is launched, the term of the contract ends when annual sales of product drops below US\$10 million per annum.

LifeScan is a former partner of UBI's which commercialised and further developed UBI's diabetes strip and meter technology. Using UBI developed technology, LifeScan has sold more than 10 billion diabetes strips globally. LifeScan's comprehensive portfolio of diabetes related products and technology is recognised amongst the world's best.

John Sharman, CEO of UBI said "LifeScan paid UBI A\$44.6 million in 2019 to buy out UBI's royalty stream which was based on the diabetes products developed using UBI technology. Our new deal with LifeScan means that we can use our existing know-how and combine it with the LifeScan technology to develop a new diabetes product for animals, which we will own."

Mr Sharman said; "Most if not all of the technology, know-how and manufacturing capability for diabetes strips and meters already exists at UBI and we expect to have a product available for sale within 18 - 24 months. Our ambition is to win a significant share of the animal diabetes market."
